Vent and tank discharge must be installed correctly to avoid the possibility of flooding.

Raritan's five gallon Compact Holding Tank is designed to fit snugly around Raritan's Compact or PH model toilets. The Compact Holding Tank can be installed for use with a deck fitting for pump-out service (permanent) or can be carried ashore for emptying (portable). Fittings for either application are included. NOTE: For conversion, tank must be empty.


# INSTALLATION


### **MOUNTING - Permanent and Portable**

- 1. Place tank around toilet on a level surface.
- 2. Place two wooden blocks approximately 1 inch (2.5 cm) x 12 inches (30.5 cm) long along the front and side of the tank, pressing firmly so that the tank is against the bowl (Figure A).
- 3. Mark the location of both blocks then remove tank.
- 4. Fasten blocks securely to the deck in the position marked and replace tank.

# **PLUMBING - Permanent**

- 1. Install the waste pump-out (see Figure B) deck fitting (not included) in a location which:
  - a) will keep the hose connecting it to the tank as short as possible.
  - b) allows rinsing of tank after pump-out.
  - c) is away from fuel and potable water intakes.
- 2. Remove 1½" plug (#31-122). Check direction of waste pump-out fitting. Install either the straight male adapter (#31-121) or the elbow adapter (#PLA401), both are included. Connect to deck pump-out fitting and secure hose ends with clamps.
- 3. Install a vent fitting on the hull which:
  - a) is located above the tank and above waterline at full heel.
  - b) will be protected from spray or submersion at full heel.
  - c) has a loop and clamshell cover (Figure B) to further prevent against water coming in.





4. Turn discharge fitting of toilet to face intake of tank and connect using sanitation hose (#CHTT8), provided. Secure ends with hose clamps.

# **PLUMBING - Portable**

Install a vent fitting on the hull which:

- a) is located above the tank at full heel.
- b) will be protected from spray or submersion at full heel.
- c) has a loop and clamshell cover (Figure B) to further prevent against water coming in.

Turn discharge fitting of toilet to face intake of tank and connect using supplied sanitation hose (#CHTT8). Secure ends with hose clamps.

# **EMPTYING - Portable**

- 1. Flush toilet several times to clear waste hose. Do not overfill tank.
- 2. Disconnect intake hose and cover fitting with cap provided. (#CHTT7P)
- 3. Disconnect vent hose and cover fitting with cap provided. (#CHTT16P)
- 4. Remove tank from around toilet and take to a proper facility for emptying.
- 5. To empty contents, remove the discharge cap.

# **EMPTYING - Permanent**

- 1. Remove deck waste cap.
- 2. Pump-out until tank is empty.

Whenever the boat is not going to be in use, regardless of climate, the holding tank should be cleaned and stored as follows:

## **STORAGE - Permanent**

- 1. After emptying tank, flush toilet until tank is filled with clean water.
- 2. Pump-out until tank is empty.
- 3. Dilute 1 oz. (29.5 ml) of Raritan Concentrate **OR** 1 cup (.1175 liters) of household bleach in a half gallon (1.9 liters) of water and add directly to the

tank (not through toilet). This will help hold down odors and break up any solids remaining in the tank.

## **STORAGE - Portable**

- 1. After emptying tank, rinse out thoroughly with clean water.
- 2. Dilute 1 oz. (29.5 ml) of Raritan Concentrate **OR** 1 cup (.1175 liters) of household bleach in a half gallon (1.9 liters) of water and add directly to the tank (not through toilet). This will help hold down odors and break up any solids remaining.

CAUTION: When handling Raritan Concentrate or household bleach avoid direct contact with skin or clothing. If contact occurs, flush the area thoroughly with water. DO NOT put household bleach into the toilet. Damage will result.




# TROUBLESHOOTING

Refer to toilet owner's manual for toilet troubleshooting. The following apply to holding tank problems:

PROBLEM	POSSIBLE CAUSE	CORRECTION
Toilet is difficult to flush or will not pump-out	Clogged Vent Line	Remove and clean vent and line
Dockside pump will not remove waste from tank	Defective Pump	Fix Pump - Report failed pump-out equipment/operators to USCG.
	Clogged Vent Line	Remove and clean vent and line
